Appendix B: Final Report of the National Vice President for Special Projects

Dear Sisters & Brothers of Tau Beta Sigma,

Take a stroll with me today, as I share with you my happenings, results, goals, and thoughts of this wonderful organization we call Tau Beta Sigma. I am so very ecstatic to be here with you today and to have served as your National Vice President of Special Projects for the 2005-2007 biennium. Upon leaving the 2005 National Convention, I was anxious and ready to get down to work and start chipping away on our Sorority Projects. First I would like to update you on the journey of "Project Restoration Archives."

First item up for business was to really push and market the importance of "Project Restoration Archives" and get as many members involved helping with the manpower. This project has been announced on listservs, Podium, News Notes, and notes sent to District Officers. I also formed a committee to help get started on where to dig in. Money raised for this project is \$4,524, with \$3,317 being raised in this biennium. These funds paid for the petitioning documents entirely. The committee and I started with the first stage, which consisted of preserving our Petitioning Documents of almost 200 chapters (active and inactive) in acid free boxes in the National Archives in National Headquarters. I am so happy to share with you today that with a lot of help, we completed this task of raising money to purchase enough acid free boxes, several workdays in Stillwater of organizing the documents, all petitioning documents are properly preserved in the archives today!"

Preserving our National Archives and History is very important to this organization in the sense that, if we know our past, we can plan our future. If we know "who we are" and remember our roots, then this provides knowledge to our identity. Starting with the petitioning documents is a great start, but it is the tip of the iceberg and there are so many tasks yet to be done. I envision one day, that we have properly preserved archives, historical documents and tools for you, our members to reflect on our history. I would like to thank several individuals and chapters in helping this project. Thank you to all of the chapters who donated for this project and believing in this cause. Thank you to Meredith Brazzell, Lisa Croston, Andrea Shafer, Randy Kitchens, Bev Cohen, Alpha Chapter, Psi Chapter, Delta Alpha Chapter and National Headquarters Staff for being an extra set of hands in the legwork of this project.

Next up on our path, is our "Women in Music Speaker Program". It is truly an honor to have been part of this program and invite various women in of all walks of life to share with us all of their experience and expertise. I have learned so much from these women and I really love the connection that this program provides you the students. Highlights of this program for the 2005-2007 biennium consists of 17 speakers for districts conventions and this current national convention. the "Supporting music through our youth: Girl Scouts & Boy Scouts" with the idea of working with youth groups such as Girl Scouts & Boy Scouts and promoting music.

I also had the pleasure of representing our organization on several occasions throughout the biennium. I was able to attend six district conventions, TMEA in San Antonio, District Leadership Conference in Stillwater and had the privilege of installing the new lota lota Chapter at Paul Quinn College in Dallas, TX!

Appendix C: Final Report of the National Vice President for Communication and Recognition

To the Sisters of Tau Beta Sigma,

This past year has been eventful. Last summer featured a cross-country move, my first classes of graduate school, and being appointed as the new Vice President of Communication and Recognition. Entering this position was exciting; I felt truly honored to have been given this chance to serve the Sorority. I became part of a National Council that was already half-way through their Biennium. I accepted the challenge and jumped right in, ready to contribute to Tau Beta Sigma.

During this past year, I have focused on my Constitutional duties in addition to taking on some other tasks. The primary duties of the NVPCR are to handle minutes and awards. I saw that minutes for all appropriate meetings were taken and distributed; this includes the National Council monthly online meetings, our face-to-face meetings in the summer and winter, and any joint

meetings we have with Kappa Kappa Psi. I coordinated awards information with the National Headquarters and the National Council so that award and scholarship winners received the appropriate items. In the area of awards, I noted the students' desire to have a military recognition award akin to that of our Brothers. Seeing that, I created the Briolette Award to honor those members of our chapters and bands that are serving or have previously served in our nation's Armed Forces.

In regards to the area of communication, I have sought out ways to improve our national website. While the website contains a great deal of information, it is not always easy to find. There are also many dead links and misdirected files. In the spring semester, I solicited help from the national listserv and formed a team of forty-eight TBS active and alumni members. These awesome people reviewed parts of the website and provided constructive feedback on content. I have compiled a list of suggestions for improving the website and will be passing those along to the people who handle those jobs. (Appendix A.)

On our national website, we have added a chat room. I worked with the internet company to secure a web channel and chat room for Tau Beta Sigma. This room is on our website and is accessible 24/7. This room has housed our monthly Student Chats for the past year and is convenient for all members, regardless of what server they use online. Our monthly Student Chats have been a great way to share information and network across the country. I would like to see more students participate in these chats; the exchange of ideas has been beneficial for us all. Furthermore, students should know that districts or chapters could use the chat room to host business. More ways to utilize that chat room should be investigated.

This year I worked on streamlining the process for publications submissions. National Officers are expected to contribute to the Podium and all six districts' publications. This past year there were twenty due dates. I established a calendar that allowed all National Officers to submit articles to me on four different dates. I would then disseminate them at the correct time to the publishing chapters. This allowed officers to write the fewest number of articles possible and still avoid duplication. Also, publishing chapters only received one email from me, and not five separate emails. I believe that this method worked better for all involved.

The Outstanding Service to Music Award is the highest honor the Sorority will bestow on a person. This award is presented to a woman who has made significant contributions in a field of music. If you were to read the current biographies of the OSMA winners that are printed in the Guide to Membership Education, you will note that several of the articles are not written well. Upon examining these snippets, I noticed that in several instances, the bio would describe at what convention the woman was presented with the award, but not tell of any of her accomplishments. After some preliminary research on a few of the recipients, I became astonished that we were not properly recognizing these women. Over the course of the year, I have spent countless hours in the University of Maryland Music

Library Archives, where archive collections for organizations like MENC, the Midwest Clinic, and the American Bandmasters Association are held, and have rewritten biographies for almost every OSMA winner. Since some names on that list are significantly more prolific than others, this challenge was more time consuming than I had first thought it might be. But doing this project has deeply inspired me. I have developed my research questions for my master's thesis through this experience, and networking with many of these women will prove to be invaluable. (Appendix B.)

I want to say thank you to all of the students that I have met this year. You all are the future of Tau Beta Sigma. Keep that passion burning and carry it with you, even after you graduate and stop attending weekly meetings. Thank you to Chris Gordon and Wendy McCann for being gracious hosts as I flew solo to your district conventions. Thanks to Kris Wright for all of the hugs and Pez. Thank you to the Board of Trustees for their time and energy and continued dedication to TBS. Big thanks to Sue Carr, Debbie Baker, and Jean Newman for being very helpful in very different ways. Thank you to Meredith Brazzell for finally deciding that I was okay for this job. Thank you to Kimbi Sigle who was one of the first people to ever push me in TBS back in the day. Thank you to Kathy Godwin for being a great road trip companion, even though you are definitely not a morning person. Thanks to Greg Byrne for the side conversations during officer chats, the good laughs, and the winks. You have inspired me in so many ways and I am sad to see you go. So much to say and no one else cares, so here, I wrote you a card. Thank you to Adam Cantley for having a cell phone and picking up no matter what time I call you; your advice about chapter, school, life, and even what to order at Perkins has definitely made me a better leader. Appendix D: Report of the National Chapter Field Representative

From my first visit at Delta Omicron at Clarion University of Pennsylvania, to my last visit of the year at Epsilon Chi at South Carolina State University, this has been a wild ride. I have traveled 26,500 miles through 30 states. I have met with 61 chapters, nearly 110 directors and music faculty, and over 1,000 students. And I have cherished every minute of it.

The motto of the National Chapter Field Representative is "to inquire, to analyze, to instruct, to inspire." Every chapter has something to teach, and every chapter has something to learn. When I visit a chapter I have the opportunity to hear about your successes, your not-so-successes, the things you are proud of, and the things you wish had gone differently. I can then take your words of wisdom (and your words of warning), and share those with the later chapters I visit.

Every chapter I see brings a new light and adds a new facet to my ideas and appreciation for this organization. So many other organizations have a cookie-cutter version of what a "good" chapter is supposed to be. Because each individual TBS chapter has to adapt to fill the needs of its own band program, the TBS National Chapter sets the outline for each local chapter, and it is up to each individual group to determine the specifics, the projects, and their style. In other words, the National Chapter here creates the canvas, and each local chapter turns it into its own unique painting. The final result of that is a stunning collection that continues to amaze me.

During my trips I started making a mental list of the vast talents and accomplishments of our membership. I started to realize we had a lot of unsung heroes, and a lot of hidden talents within this group (great "characters," if you will). Because of this, I put out a request in the Spring 2007 PODIUM for chapters to nominate individuals from their chapters to be recognized for this. These students will be recognized in the Fall 2007 edition of The PODIUM.

One of my new priorities is to create ideas and resources for chapters to continue this level of personal communication and interaction. Some chapters have the luxury of being near a National or District figure of Tau Beta Sigma, but most do not. The face-to-face communication brought by a CFR visit should not stop when there is no CFR visit scheduled for that semester. I strongly encourage chapters to travel and to visit with other chapters. More specifically, I want you to visit chapters and schools that are not like yours. If you, as a chapter, are only communicating with other chapters who are of like mind, you can only learn so much. If you communicate with chapters who do not have the same experiences, resources, and style of operation as your chapter, there is so much more that you can learn and teach. You can facilitate this and accomplish it for yourselves; you don't need me for that.

I have an exciting year planned ahead of me, and I am extremely excited to announce my schedule for trips for Fall 2007. I will start the year with the Southwest District in Oklahoma and Texas, then up towards Ohio and Michigan in October, then end the trip with a drive out to the west coast for my first visits to schools in the Western District. In light of the future changes to the program, while creating this schedule I also ensured that my trips for this next year would cover as much of the country that I could, aside from the areas I have already traveled in. As of today, my 2006-2008 visits include 76 chapters and colonies. Shortly after National Convention I will begin the communication and preparation for these visits.

Near the end of each of my chapter visits, I get a chance to meet with the entire group at one time. Prior to the visit, I send ahead several forms to help the chapter understand and prepare for the day. One of these forms includes a place for the chapter, as a whole, to discuss its strengths and weaknesses, among other things. This helps the chapter to self-assess, in a way, before my visit. It gives them a chance to celebrate victories and discuss issues that may have not already come up in discussion. When I arrive we talk about these, and whatever else may come up, during this full chapter meeting time. As I was writing this report, I started to think, "What would we talk about if the entire National Sorority were together for one of these meetings? What would I share about my experiences on the road?" Since this is as close as we are going to get, I thought I would share those with you:

- Don't ever compare yourselves to another chapter as a whole. Every chapter has different strengths, weaknesses, resources, and experiences. You have different schools, directors, ensembles, administrations, ΚΚΨ, ΦΜΑ, ΣΑΙ, ΜΦΕ, different alumni, and different potential future members. Even though you may be located right down the street from another chapter, you have completely different needs, and completely different resources to draw from. There is no reason you should feel the need to function the same way, or have the same projects or the same number of members as the chapter down the street. Chapters reach their highest potential in a certain area when they are working to find the best projects and solutions that work for them. And the only way these chapters can continue to reach this potential is to be constantly assessing themselves and tweaking (or even overhauling) their operations and traditions. Just as your school and band program are constantly changing, your chapter needs to change along with them.
- Thank each other. When I tell people "I have the best job in the world" (and I do), I go on to explain that I get to work every day with college band students who arrive early to work before rehearsals, stay late to work after concerts, do whatever is asked of them (and sometimes before they are even asked), and they don't feel the need to be compensated or thanked for it. That's not entirely true. Everyone needs to feel appreciated, so appreciate each other within your chapter.
- Make decisions together. When I read a chapter's self-assessment, one of the top two weaknesses is usually "Participation" or "Motivation." When chapter members are handed down a big list of events at the start of the year, or told two days in advance of a "mandatory" activity, the active membership no longer feels as if they have ownership over the activities and decisions of their own chapter. Decide as a group what you are going to do, how much you are going to do, and when you are going to do it; take it to a vote, and then follow-through with the result of that vote. A person will feel a greater responsibility and drive for something they have a hand in deciding.
- Talk. While "Participation" or "Motivation" is one of the top two common weaknesses for chapters, "Communication" is the other. We live in an age of cell phones, facebook, and instant messaging. However, as tools for communication

seem to be multiplying, actual communication is declining. Honestly, the best communication strategies I see in chapters now are: bulletin boards in the hallway or bandroom, or 5 minute meetings after each band rehearsal. Communication issues are also not necessarily a chapter problem, they are an individual problem that becomes a chapter problem when an individual drops the ball. My biggest encouragement for you: don't be that individual. Just take the time and effort to communicate, and encourage your chapter members to do so as well.

To Kimbi, thank you for the freedom to learn what works best for me, and letting me run with it. To Kathy, thank you for your honesty and feedback on my ideas, no matter how scatter-brained they can be. To Dawn, I am so glad to see you on the council; your passion for everything you do is contagious. To Dollie and Carolyn, your support and ideas never seem to wane. Your CFR stories keep me rolling with laughter, and I can't wait to stand with the two of you and add my own as we tell our stories to the next Chapter Field Representative. To Greg, thank you so much for your insight and fresh ideas for this organization. To Jean, thank you for being a calming voice of encouragement, and for helping me stay grounded. To Sue, I will never have a better conversation at 3 o'clock in the morning. To the Alpha Chapters of Tau Beta Sigma and Kappa Kappa Psi, and to National Headquarters: Alan, Dixie, Di, Debbie, Jake, and to Phil. You are my family and my home away from home. Never has a move half-way across the country been so easy.

To the chapters of Tau Beta Sigma, I thank you all for this fantastic, wild ride. I hope with each visit I am able to show you a glimpse of the sorority as I am honored enough to see it.

As a band director, I've enjoyed serving on this council. The council operated much like a band director would operate their band program. Program Development was a focus, trying to look beyond the next two years.

We were given a directive by your President to put ideas to action, yet have ideas that have a lasting impact on the sorority. As a result, my colleagues and I have been busy implementing projects and programs to make Tau Beta Sigma stronger and better in the years to come.

I am excited about the large scope projects that Dollie has been working on over the past two years. Many of these projects are in their infancy stage, much like the National Intercollegiate Band was some sixty years ago.

According to Alan Bonner, this biennium has had a record number of applicants. The number of TBS members in the band has increased by 1300 percent.:) This project as well as the reading band are reminders to all of us that music making together plays an important part of our existence and motivations.

Appendix J: Report of the Western District of Tau Beta Sigma

Where's it at? WESTSIIIIIIIIDE!!!

The Western District has refocused itself this last biennium on the fundamental elements of our organization: music, service, leadership, and our Factors and Qualities. These concepts have become central to all of the activities and programs that we have developed and implemented over the last two years.

Instead of just giving a laundry list of our accomplishments, I want to give you an overview of all the events and trends, both positive and negative.

Although being the smallest district can sometimes have its disadvantages, such as having to drive hours to the closest chapter, this biennium brought stronger ties among us all as we had some of the strongest attendance at our district events yet. One of our most successful events was the District Leadership Conference held in January 2006 in San Luis Obispo, California for a record 150 people. Our joint district councils worked for months to revolutionize this event, particularly through a concentration on a new philosophy: to focus on the fundamentals of service, music, and leadership and to prepare, educate, and provide resources to our members. This was accomplished through various workshops, some of which included "Keepers of the Bond: Big Brothers/Big Sisters," "Risking it for Results" and "Ok, so you an active, what's next?" In addition, we experimented with several new program ideas that we felt would fulfill our purposes as well as strengthen the bonds between our members. These included a Non-Traditional Music Talent Show where our Brothers and Sisters made music with anything from straws to pots and pans to coughing, a new ceremony called The Western District Joint Experience, a giant game of twister, a service project to clean and organize the Cal Poly band room and uniforms, and PJ's and Hot Chocolate time that allowed all members to reflect on their feelings and experiences with the event and with Tau Beta Sigma/Kappa Kappa Psi in general at the conclusion of each day of DLC. This event's success was truly a testament to not only the hard work of the council, but also to the quality and work ethic of our members.

Our two district conventions this biennium have also proved to be a great success. The 2006 convention in Ontario, California again saw our biggest turnout to date with 350 people and the implementation of several new projects including student conductors in reading band and a reduction to only essential committees so as to allow our members the opportunity to attend the larger number of workshops that we offered. Our 2007 convention was held in Las Vegas, Nevada and again saw vast improvements in structure and content. We held more workshops, heard from more women in music speakers (including Kirsten Brooks from VH1's Save the Music), and even invited a local high school ensemble to hold a concert for our members.

Over the past biennium we have also tried to increase the number of fundraisers while making sure that these do not become a financial burden on our members. While we still created new district t-shirts and other apparel to be purchased, we also tried to focus on fundraisers where our members did not have to buy items to benefit the district. Our most successful ventures have been restaurant profit-share fundraisers at district events and TV Tapings where our members were paid to be audience members for TV shows. We have raised funds in our budget to the highest it's been in years and will continue to work towards fiscal growth and stability.

Despite these successes, this biennium did not come without its fair shares of challenges and changes, especially in regards to our District leadership. Our Vice President of Membership was forced to step down from office as she was unable to meet and fulfill the requirements of active membership in her chapter. Additionally, the remaining council voted to remove the Vice President of Special Projects from her office due to lack of accountability and her failure to meet deadlines set by the council. Theses losses were extremely difficult, especially at a time where planning for convention was in full speed.

To make up for this lost ground, we created Program Chairs to allow for district members to help fill the voids left by these vacancies. We quickly collected applications for responsibilities that would have fallen to these officers. These Program Chairs were: Women in Music Research Program, the Ambassador Program, the Post-Membership Education Program, the Travel Research Program, District Scrapbook Program, and the Buddy Chapters program. The District Council appointed these chairs to begin working immediately for the next month on their specific program, which they would then present to our membership at our district convention. Although this was a difficult and time-consuming process, the end result was so positive that

we are continuing the Program Chairs process throughout this next biennium. This program allows our members to help on a larger level and to gain district experience, as well as help our District Council the ability to focus their energies.

As you can see, we encountered and persevered through many obstacles this biennium, and we truly believe that we are stronger because of it. We have seen our chapters and members step up and help without hesitation when our district was in need. These attitudes and actions established a strong foundation of Sisterhood and leadership in our district. Our District, our chapters, and our members have even been honored to receive recognition from the National level. In addition to holding the National Spirit Stick for this biennium, our chapters and individuals were recognized with the following: an Outstanding Sponsor Award, two Baton Awards, and one chapter recognized as a Grace and A Frank Martin Chapter Leadership Award Finalist.

As we look forward to the next biennium from the West, we see greater change on our horizon. It is the goal of the 2007-2008 Western District Council to continue the focus on issues we feel most central to the sorority: music, service, leadership, and our Factors and Qualities. We aim to give our members the most resources, communication, support, and leadership development opportunities possible. Our challenge will be creating projects, activities, and workshops that continue to benefit our members in this more focused direction.

In short, we want to show that truly, "The Best are in the West!"

- 9. Discuss how we can utilize our history to help build for the future. How does our past shape or impact the path for concepts such as marketing to potential students and directors?
- 10. Create short history lessons for chapters to use within their Post Membership Education programs use information from each of our six decades.
- 11. Discuss the "Past National President" forum & "Wava Session" and any ideas for future sessions.

After reviewing the information from the 2005 Team History Committee Report, we delegated the recording of our historical happenings at this convention which will be compiled and taken back to our archives. In addition to the interviews and pictures that have taken place, the committee discussed the importance of our history, the desire to know more details through documentation and anecdote, and the necessity of the national and active chapters of our organization to utilize all history available to progress forward in our endeavors. Through our discussions we would like to charge the following:

To the 2007-2009 National Council:

- Establish a Committee and consider reinstating the appointed position of National Historian in order to gather and recover historical documentation that will be compiled into several resources. This committee should be utilized to do the following:
 - Have a proposal to be presented at the 2009 National Convention for a textbook-style publication to include such information as the Beta Letters, their counterparts which are contained in the National Archives, and all supplemental documentation throughout the history of our organization starting pre-incorporation time period.
 - Compile all media resources such as video recordings, pictures, and cassette tape interviews. Explore the availability of the national website to host clips of such media
 - Begin a restoration and catalogue process of the current media by converting everything to DVD. Create
 an organized manner in which to have an index in
 the National Archives of what we have and where it is
 located. These DVDs should also be made available to

- the active chapters by the best means possible and is to be actively marketed as a resource.
- 2. We charge the National Council to make the following forums available at the 2009 National Convention:
 - Continue the "Wava Session" as available
 - Continue the "Past National Presidents Forum" with more detail of where they are now and what they are doing in all aspects of life, not just the sorority.
 - Begin opening separate session with a prominent member of our historical past to charge us into the next biennium with their dreams and inspiration for the current and future actives.
 - Host a forum with a member of the Board of Trustees to allow us to see who they are and what they do for us.
 - Host a forum with a member of the Tau Beta Sigma Alumni Association so we can see where they have come from over the biennium and where they are planning to go in the future.

To the 2007-2009 National Vice President of Colonization and Membership:

 We charge you to create short outlines of historical lessons to be used in post-membership education as a supplement to the history given in the National Membership Education Program. These lessons need to be marketed and made readily available to the active membership prior to the 2009 National Convention.

To all actives chapters of Tau Beta Sigma:

- 1. We charge you to continue your historical efforts through the following:
 - Create yearly detailed descriptions and records of events and accomplishments in addition to pictures and scrapbooks. Consider utilizing Fall Activity Reports and Chapter Summary Reports to do so.
 - Advance the preservation of previous chapter history resources through cataloging and creating a secure area for chapter archives.
 - Create mini-lessons of chapter specific history to membership candidates as well as the active membership.
 - Explore the possibilities of celebratory acts such as time capsules and banquets.
 - Explore new ways to maintain family trees by looking into documentation formats and online options.
 - Expand your alumni network through the possibility of a pen pal system with your own chapter alumni.

In addition to these charges, we would like to recognize the following historical events and accomplishments of the past biennium:

- 1. We celebrated the 60th anniversary of our organization
- 2. Six colonies became chapters ending with lota lota at Paul Quinn College in April of 2007.
- 3. The National Chapter Field Representative Program was re-instated.
- 4. The National Archives Project began and phase one has

been completed.

- 5. The Disaster Relief Fund was established.
- 6. The Johnny B. Vinson Award was established to recognize professionals who support Women in Music.
- 7. The National Alumni Association has been restructured to better benefit our organization.

We would like to thank Janet West Miller and Karon Miller Hammond for attending and being involved with our discussions. Additionally, thank you to John McArthur, Amy Fitzpatrick, Heather Sony, Mackenzie Cochran, LaRae Smith, and Laura Pokorski for all of your additional efforts with interviews and pictures. Lastly, we would like to thank our advisors Renee Cartee and David Hammond for your outstanding guidance.

FINAL REPORT OF THE COMMITTEE ON RITUAL AND REGALIA by Stacy Laue, Theta Mu, University of Nebraska at Kearney

The 2007 Ritual and Regalia Committee was charged with the following:

Review the 2005 Ritual and Regalia Committee Report.

- Review the contents and qualities of the new Ritualin-a-Box
- Discuss any Sorority Regalia and Merchandise needs such as robes, new banners, etc.
- Create a list of topics to be covered in a History of the Ritual document.
- Discuss what topics regarding Ritual or History are of interest to the membership. List some possible ideas that could be useful workshop topics at District Conventions or other Sorority events.
- Discuss ways to further educate members regarding the Ritual to build our Sorority.

The Committee reviewed the 2005 Ritual and Regalia Committee report and accepted the contents as written.

The Committee reviewed the contents and quality of the Ritual-in-a-box and recommends the following:

- Provide a stand on the back of the photo frames so that they may be visible to all.
- Charge the National VPSP to compile a list of possible places and/or locations whether on the internet or around the nation that a chapter may find a box with safety features, such as a lock, with which the Ritualin-a-box items would be kept.

The Committee discussed Sorority Regalia and Merchandise needs and recommends the following:

 Make available the information as to how to purchase such merchandise and where to find the information.

The Committee created a list of topics that may be covered in a History of the Ritual document:

- The purpose of Ritual and how it changed over time.
- Was our Ritual modeled after the Kappa Kappa Psi Ritual?
- The origin of the 8 and 5.
- The original attire at Ritual and how that came to be.
- The location of the first performance.
- The author(s) who wrote the original Ritual book.
- An explanation of why items such as symbols on the altar, our flower, the colors, and handclasp were chosen.

The committee discussed many topics regarding Ritual or History that may be of interest. We created a list of possible workshop topics that will further the education and understanding of our Sorority. These are as follows:

- · Learning about the different Degrees.
- How to use the 8 and 5 values in our everyday lives.
- Creative styles that may be used to refresh the minds of our membership about Ritual and how VPM's may keep actives interested.

- A new member workshop on Ritual.
- Running and performing successful rituals.
- Good ways to learn and retain the Loyalty Song and National Hymn so that we may all sound as one.
- Appropriate music that might be played during Ritual ceremonies.

The Committee discussed ways we could further educate our members in reference to Ritual and recommends the following:

- A notebook containing written materials about our history and how to be a sister that may be given to members for as long as they are members of our Sorority.
- Giving weekly tips as to how to use the 8 and 5 in our daily lives that might be called "Wava Reminders".
- Take a few minutes at each meeting to bring out a special Ritual object and use it to inform the chapter about the object.

- Future charges need to be more detailed, so that the committee may have an exact idea of what they need to discuss.

Final Report of the Colonization and Membership Committee

This year's colonization and membership committee focused on furthering our sorority on a national, district, and chapter level.

We reviewed the charges given to us from the 2005 national convention membership committee. We were first charged to discuss ways to break stereotypes, and make the sorority marketable to a variety of people.

The common stereotypes we discussed are the following:

Band Geek- break by being proud of whom you are Friends because of the Organization- break by judging qualities and that we are honorary sorority, we have no legacy status.

Others thinking we are stuck up- break by Act Humble, get involved in things without just active TBS all the time but invite others to help. Open a meeting to the whole band/personal.

Others thinking we are a cult- break by speaking positive to the person who states the comment. Be open about some things, but keep ritual/ceremony secret and closed. Use the term Ceremony to explain situation. Choose your words wisely.

Others thinking we are girly- Break by showing the pictures of male members, In band dress alike, I am a person too.

Others thinking males in TBS are not masculine- Break by presenting yourself as whom you are, joining with other males and show males are allowed to be. Foster better relations with joint KKY chapter show the positives of working together. Both organizations have different personalities and qualities. Choose organization through recruitment. Cannot discriminate against sex Title 9

Lack of respect due to youth of organization- Break by keep building members and staying strong.

Our next charge was to discuss the Tau Beta Sigma recruitment and marketing DVD and it's uses on active campuses.

Some of the ideas we came up with to promote the use of the DVD are as follows:

• TBS @ the College Level Notes: Ideas for the use of the film: Band director conferences, use the film for the universities student organization day, use the film for outreach at high schools, and give the film to band directors/sisters to use. Use the film for honor band programs.

 How to start a colony notes: Ideas for the use of the film: Use the film at the chapter level if you are advising a colony, use the film for a recruitment package.

The committee was also charge with discussing ways to build internal membership through marketing to all bands.

The following are the marketing tools we discussed:

- DVD
- Show other bands what you do with letters on things.
- Have a social with other groups.
- Receptions after recitals and band concerts.
- Work along with other sororities and fraternities.
- Be sure you know what your chapter is about to help explain to new people
- Start marketing at the high school level.
- · Market to High school band councils.
- Show through your personal experiences to members
- Send info about college bands and intertwine TBS and KKY information.

Next we discussed ways to set or build on a foundation of communication with directors on campuses were we already have chapters.

The following are the ways to build on the foundation of communication with directors:

- Make sure they are involved
- Do what you are suppose to do/being on task
- Communication
 - \sim Invite directors to chapter meetings to work together to achieve a goal in the directors perspective and the chapters perspective.
- Have them review top three offices
- Invite other instructors to social and service programs that are taking place in chapters.
- President has to send bi-weekly report.
- Make sure the director understands what you do and what it takes to get the project done.
- Encourage TBS members to be band officers.
- Band officers and not allowed to be TBS or KKY members.

After that we discussed the importance of strong chapters and members in order to achieve expansion.

We are TBS, starting to using the power of voice on each level Chapter, District, and National.

Ideas to Improve Local level:

- Represent organization at all times, i.e. band rehearsal, school, work, parties...
- Quality vs. Quantity
- Cannot build on a weak foundation/need to be unified separately and jointly if applicable
- Build leaders in your band programs- MOTTO OF NATIONAL CONVENTION "FROM THE BAND UP"

- Delegate through out your chapter with clarity so the job gets done
- Tap into your chapters talents to make funds as well as participation: Example: Sisters who can cook...bake sale

Ideas to Improve District level:

- Use stronger chapters in districts to help and promote weaker chapters
- Learn from stronger chapters to follow what we stand for.
- Cannot expand districts without expanding strength in chapters.

Ideas to Improve National level:

 Start at the bottom, and watching intake at the chapter level.

Finally the committee's last charge was to review the graduate membership proposal given by the national council.

The first proposal given by the national council failed to pass through the committee. This occurred due to the details given in the proposal. The set proposal was to create a new membership status for graduate students in the field of music. This status would be known as collegial membership. It proposed to allow graduate music students membership in the sorority by paying a \$40 fee to network through our sisterhood.

This first proposal required no membership education program, and allowed only music education students to qualify for this status. The problem seen by the committee was that membership is privilege and that should not just be handed out to just anybody.

Members of the committee then created a new proposal. The change made was to take the membership status and amend it into a Graduate Student Affiliation. This proposal also offered the same fee and benefits without membership in the sorority. This proposal also offered a requirement asked of the graduate students whom want to take part, instead of instant membership. This proposal passed in the membership committee and was sent to jurisdiction.

The committee then was able to focus on charging the 2009 colonization and membership committee.

The following are the charges for the 2009 committee:

- 1. Review the 2007 membership committee and the 2007 colonization committee report.
- 2. Review the new graduate student affiliation, its progress, and its effectiveness.
- Discuss ways to improve on individual chapter recruitment.
- Review and evaluate the membership DVD and its effectiveness.
- 5. Discuss current strengths and weaknesses of the sorority and how to improve on membership quality.
- 6. Discuss and suggest ideas to the current VPCM on how to implement the recharter of inactive chapters.

The Separate TBS Publications Committee of 2007 was charged with the following:

- 1. Review the 2005 Publications Committee Report and 2005 Website Committee Report.
- 2. Examine the Tau Beta Sigma website (www.tbsigma. org). List suggestions for improvement in areas such as: content, layout, and accessibility.
- 3. Review the Sorority manuals on the Resource CD: Chapter Operations Guide, Guide to Membership Education.
- 4. Evaluate the TBS Resource CD, now online. List suggestions for improvement.
- 5. Determine what additional information should be provided to chapters in a published format (either CD, web, or paper).
- Determine ways to encourage membership to use the resource information on line or in alternative ways, as the material is important to the foundation and future success of the Sorority.

We began our meeting by discussing the tasks completed by the 2005 Publications Committee and the tasks given to us, the 2007 Publications Committee. The first topic we discussed was the TBS Resource CD.

Charges:

Resource CD

 We charge the National Council to continue with online resources, and to only create Resource CD's upon request.

Content on website, etc.

 We charge the Districts to provide the National Council with any Audio Versions of Tau Beta Sigma songs.

- We charge the National Council to distribute the songs (midi, etc.) to chapters via website.
- We charge the National Council to create a project database with ideas and samples of successful programs for membership, service, fundraising, communication, social, public relations and other aspects of chapter functions.

Chapter Operations Handbook and Guide to Membership

- We charge the National Council to complete the 2005 charges and changes for the Chapter Operations Handbook.
- We charge the National Council to add color graphics to forms and publications, so chapters will have the option to print materials in color.
- We charge the National Council to include biographies of the founding members under the "history" section of the website, and in the Guide to Membership Education.
- We charge the National Council to update the names of Emily SoRelle and Rose Nell Williams in the Guide to Membership Education.
- We charge the National Council with creating with a list of specific ways to teach post membership education, by expanding page 10 in the Guide to Membership Education.
- We charge the National Council to expand upon the information about early influential people, including D.O.
 Wiley and A. Frank Martin, etc.
- We charge the National Council with researching and implementing a password protection for viewing the Guide to Membership Education online.

Website Layout, Content and Appearance

- We charge the National Council to place all of the forms on one page (http://www.tbsigma.org/resources.html), and to offer alphabetical, categorical and due date viewing options.
- We charge the National Council to investigate the compatibility of online forms (PDF and Word), so forms can be utilized on a variety of computer systems.
- We charge the National Council to investigate the feasibility of adding a message board to the website and separating forums into categories such as upcoming chapter and district events, social, service, recruitment, fundraising, and Post Membership Education.
- We charge the National Council to create an interactive United States Map of active chapters and colonies.
- We charge the National Council to create a Tau Beta Sigma historical timeline, to be included under the "About TBS history" column on the website, and as a document available for chapters to use in their membership education programs.
- We charge the National Council with adding more historical information in addition to what is already on the website.

- We charge the National Council to make sure that there is a consistent look and feel throughout the entire website, and to fix all dead links.
- We charge the National Council to create an interactive calendar of events and deadlines, with links to forms and other helpful information contained elsewhere on the website.
- We charge the National Council to create a new link titled,
 "Convention Workshop Resources", under the "conventions" link off the tbsigma.org home page.
- We charge the National Council to include the actual email address of the officers, in addition to the hyperlinks under the "Contact Us" portion of the website.
- We charge the National Council to compile all of the alumni resources onto one page that is easily accessible off of the tbsigma.org website.

Joint

- We charge the joint National Councils to update The Podium website on kkytbs.org to provide a link to the current issue and contain the online archives, once created.
- We charge a more prominent link to the email address for submissions to The Podium.

 Develop a list supplies and/or paraphernalia that you would like to purchase through National Headquarters or at District Conventions.

The committee determined the winner of the District Spirit Award based on the following criteria:

- 1. Singing/cheering
- 2. Clothing Days

- 3. Attending ritual
- 4. Participation in Reading Band/Auxiliary clinic
- 5. Attending concerts/workshops

The topics discussed in the meetings were as follows:

- 1. Ways to strengthen the bonds of sisterhood between chapters, focusing especially on those chapters that are separated by a large physical distance.
- 2. Ways for students to meet, share ideas, and create a network with members of other chapters while in attendance at National Convention.
- Compile a list of paraphernalia that students may be interested in purchasing through National Headquarters or at District Conventions.
- 4. Ideas to implement sisterhood within chapters, as well as activities to incorporate into Sisterhood Week.
- 5. Created new, short, generic cheers/chants/calls to implement into all chapters to encourage cheering and participation in spirit.

Discussion

- 1. When discussing ways to strengthen the bond of sisterhood between chapters, as well as focusing on chapters that may be separated by a large distance, the committee developed the following ideas:
 - a. Pen Pal Program (Active Membership participation as well as Membership Candidates)
 - b. Meeting at a halfway point for an activity or retreat so driving may be equal in distance.
 - Invite other chapters to retreats, service projects, fundraisers, rituals, or any other eligible joint activity that may promote sisterhood (i.e. DCI Shows, Step Shows, etc.)
 - d. Football/Basketball Games: Arrange a reception or mingle session during half time or third quarter.
 - e. Internet Resources: Facebook Groups, Myspace, Xanga, Blogs
 - f. Statewide Activities (State Day)
 - g. Sending Cards on Holidays

PROPOSED PROGRAMS

"Promoting Music through our Youth in Scouts" Program

The committee reviewed the proposal by the NVPSP: Help Boy Scout & Girl Scout troops earn their music badges.

- To promote music through educating our youth.
- To begin in Fall 2007
- Encourage chapters to contact local troops and set up a workshop to help earn music badges

Committee Recommendations

FINAL REPORT OF THE COMMITTEE ON WAYS AND MEANS By Kellie Mae Cozart, North Central District President Theta Chapter, University of Cincinnati

The 2007 Tau Beta Sigma Ways and Means Committee was charged with the following:

- Review the 2005 Ways & Means Committee Report.
- Discuss any dues or chapter fee increases that may affect the Sorority.

- Recommend for approval the submitted budget for the 2007-2009 Biennium.
- Examine the current practice of using this limited committee time to review and adjust the budget proposal. Determine the effectiveness of utilizing the committee to review the budget versus asking other leadership (district officers and counselors) to submit feedback prior to convention.
- Explore the following topics and determine their priorities within our fundraising:
 - Rescue Our Rep
 - Archives Fundraising
 - Chapter use of vendors for fundraising

The 2007 Ways and Means Committee reviewed the 2005 Ways and Means Committee report.

Membership Dues and Chapter Fees support the cost of doing business in a fast moving society. Maintaining Stillwater Station, employing five staff members, computer services, scholarships, the Women in Music program, Archives, and several other projects are dependent upon a balanced budget. Historically, active membership, honorary and initiate dues, and chapter fees were broken down as follows:

As Tau Beta Sigma continues to grow and flourish, it is important that the national chapter use good business sense. Due to an increase in travel costs, utility prices, and insurance, the Ways and Means Committee proposes that the dues and chapter fees increase according to the following table:

It is also important to note that Kappa Kappa Psi is proposing a \$250.00 increase to the Life Membership fee. The Ways and Means committee felt it was important to note that, at this point in time, Tau Beta Sigma does not feel the need to mimic this decision. For the 2007-2009 biennium, the Life Membership Fee will remain at \$250.00.

At the 2003 National Convention, the Ways and Means Committee, with approval of the delegation, decided to suspend the CFR position until a time when funding was available. During

the 2005-2007 biennium, the CFR was reinstated after tireless work from the National Council. However, with the addition of the CFR in 2006, Tau Beta Sigma ended the biennium with a deficit of nearly \$36,000. After adding a contingency fund to the 2007-2009 biennium, it became readily clear that continuing the CFR program at the end of 2007 would not only be financially irresponsible, but not feasible.

Although the committee is making a recommendation to remove the CFR position, it is charged that the RoR Campaign continues and remains a high priority for the National Council of Tau Beta Sigma.

In addition to the Rescue our Rep campaign, the committee highly recommends that the National Council put an equal emphasis on the Project Archives. It is understood that that these two projects will take a significant amount of fundraising, but after tireless amounts of discussion, an importance could not be placed on one or the other.

Some chapters may try to consider what they can do to help the National Chapter save money. Did you know that National Headquarters spends an average of \$5,000 per biennium on telephone services including the 1-800 number? This is where you come in! Please put out your cell phone. With the now wide availability of free long distance via cell phone, the Ways and Means committee wanted you all to have the official number to reach any of the personnel at National Headquarters. The phone number is 405-372-2333.

The process of creating and implementing a budget is a process that is no where near simple. The National Vice President of Colonization and Membership spends nearly two months preparing and discussing the budget for the upcoming biennium. This budget is reviewed by members of the National Council, Board of Trustees, the Executive Director, the National Accounting Firm, and Past National Presidents. The 2007 Ways and Means Committee felt that the process of allowing the students to review and present the budget was an integral part of leadership development within Tau Beta Sigma. Though being a member of this committee is no easy task, the knowledge gained is immeasurable. As a result of this, the committee felt that the National President should continue to assign a Ways and Means committee each biennium, with the following improvements:

- 1. Attempt to find more qualified committee members with accounting or budget writing experience. This could be a separate field added to the Convention Delegate form for chapter representatives.
- Provide clear, written explanations as to reasons for proposed increases and decreases in budgeted amounts
- 3. Provide a listing with each line item of the personnel responsible for expenditures in that category
- 4. Provide income and expense statements in two separate documents so that a direct side-by-side comparison can be made.
- 5. Require the National Vice President of Colonization and Membership, Executive Director, and National Head-

quarters Accountant to be present at the first meeting of the Ways and Means committee. With these resources in one location at one time, it will be possible for the committee to receive a more well-rounded explanation of the budget and its contents.

The 2007 Tau Beta Sigma Ways and Means Committee wishes to recommend for approval the revised budget for the 2007-2009 biennium as follows: (Insert Excel Worksheet here)

The Ways and Means committee charges the National Council to:

- Individually assign each line item to the appropriate member of the National Council or National Headquarters Staff. Upon assignment, it is requested that all parties remain as financially responsible as possible to ensure that all expenses come at or below projected values.
- 2. Promote the use of allotted money for "District Officer Travel"
- 3. Conduct an intense review of the budget twelve months after the start of the new biennium to see potential issues and areas of overspending.
- a. Following the review, report all findings and budget updates to the District Counselors and Presidents via e-mail and/or US Postal Service.
- b. Once the reports have been received by the district personnel, it is recommended that the National Council hold a phone conference to discuss the report and answer any questions
- 4. Implement and evaluate the improvements to the Ways and Means committee structure as stated above
- Create a listing and widely publicize how chapters can fundraise for the National Chapter without directly taking funds from their bank accounts (i.e. using Care-Clicks, GoodSearch, Purchasing bricks, etc.)

The Ways and Means committee charges the National Publications Manager to:

 Insert instructions for how to stop receipt of one/ multiple subscription(s) for households receiving duplicate copies of the Podium

The Ways and Means committee charges the 2009 Jurisdiction Committee to:

- 1. Create a definition of financial responsibility.
- Provide consequences for financial irresponsibly pertaining to the National Officers, Counselors, District Officers, and Executive Director when discussing expenditures from the national budget.

The Ways and Means Committee Chair recommends that the National Council supply an electronic copy of the proposed budget to the 2009 Committee Chairs in an editable format (i.e. Microsoft Excel), to ease the process of editing and formatting the budget.

Every member of the 2009 Ways and Means committee has worked hard to ensure that sound financial decisions are made on behalf of Tau Beta Sigma. I would like to thank each of them for their hard work, and readiness to share ideas and opinions. I would also like to thank _ for her willingness to jump in and serve as our Secretary, as well as our advisor Wendy McCann. Finally, I would like to thank all of the people who came in to talk to the Ways and Means committee to answer and clarify all of our questions. Thank you to Col. Alan Bonner and National VPCM Kimbi Sigle for their dedication to this committee.

Appendix T: Final Report of the Chapter Leadership Committee

The process for determining the winner of the Grace & A. Frank Martin Chapter Leadership Award began at the close of the 2005 National Convention. Every chapter was eligible at the beginning of the biennium. Over the last two years, the field of chapters was narrowed based upon late paperwork and any disciplinary actions. At the end of the biennium, the National Council still had over 50 chapters in the running for the Chapter Leadership Award.

The National Council reviewed all of the Fall Activity Reports and Chapter Summary Reports of the remaining chapters to select 11 finalists. The 11 Chapter Leadership Finalists are:

- · Alpha: Oklahoma State University
- Beta: Texas Tech University
- Theta: University of Cincinnati
- Alpha Xi: Bowling Green State University
- Beta Eta: University of Maryland
- Beta Xi: University of Florida
- Epsilon Epsilon: Kutztown University
- Epsilon Kappa: University of California, Los Angeles
- Zeta Kappa: Albany State University
- Zeta Upsilon: West Chester University
- Eta Phi: Vanderbilt University

The 2007 Chapter Leadership Committee convened with the daunting task of selecting the recipient of the 23rd biennial Grace & A. Frank Martin Chapter Leadership Award. Each of the finalist chapters submitted a report and the committee heard a 10-minute presentation followed by a 5-minute question and answer session from each chapter. The committee used the following criteria for determining the award recipient:

- Service to college/university band
- Service to the community
- Financial assistance to the college/university band program
- Submission of nominees for National Awards
- Leadership and participation in the band, district and Sorority
- Participation in the National Intercollegiate Band
- Chapter growth, retention, and education
- Chapter Leadership Award Report and Oral presentation

Based on these criteria the committee selected the Epsilon Kappa Chapter at the University of California, Los Angeles as this year's recipient.

We would like to commend the chapters for their hard work in preparing their presentations and for all of the creativity and energy they brought to the committee. For the first time this year electronic media was allowed to be used for the formal presentations. Not every chapter utilized this format and because of this each presentation had its own unique style and made the experience of being on the committee difficult, but also very exciting. It made our job fun, while still being one of the most challenging tasks any of us have ever tackled.

The committee would like to recognize the great variety of community service that the finalists are participating in, the depth of service was most impressive and is to be greatly commended. Some of the outstanding service projects both to the band and to the community performed by these chapters include:

- Completely renovating the storage area which houses marching band uniforms, instruments and color guard equipment.
- Mentoring band students from a lower income school who would not have the opportunity to work with university musicians.
- Designed, painted and re-decorated a children's room as part of "Adopt-a-Room" program for a family shelter.
- Provided "Turtle" Taxi for incoming freshman who do not have cars.
- Complete inventory of the band library
- Demonstrated instruments at local elementary schools
- Participation in various "walk" fundraisers, Relay for Life, MS, Walk for a cure, Memory Walk etc.
- Girl Scout Badge workshop

The committee would like to make the following recommendations:

- 1) For the first time electronic media was allowed to be used for the presentations, we recommend that this be allowed to continue as long as it is financially feasible for the Sorority to provide the necessary equipment.
- 2) We encourage all chapters to seek out opportunities for recognition on the national level including applying for awards, Podium submissions, and NIB participation. These are means that allow the nation to recognize the great things your chapters are doing.
- 3) We encourage future Chapter Leadership finalist to enlist the help of as many members of your chapters as possible to develop and participate in the preparation of the report and the presentation.

Every one of your chapters is now eligible to be a 2009 Grace & A. Frank Martin Chapter Leadership Award Finalist. Continue to submit your paperwork and provide the great service to your bands, school, community and sisterhood while following the ideals of Tau Beta Sigma and there is a great chance you will be a finalist.

It has been challenging and rewarding to serve you and it has truly been an honor.

Appendix U: Final Report of the Jurisdiction Committee

2007 Tau Beta Sigma Separate Jurisdiction Committee Charges

Chair: Meghan Fay, Western District President **Advisor:** Chris Gordon, Southwest District Counselor
Theresa Graves, Alpha Delta Alumni

Charges:

- 1. Review the 2005 Jurisdiction Committee Report.
- Consider changes to the National Constitution as proposed.
- 3. Consider changes to the National Constitution brought by other committees.

Discussion:

The Jurisdiction Committee reviewed the charges. The Jurisdiction Committee respectfully submits the following recommended changes to the National Constitution:

That all typographical or spelling errors, grammar, and renumbering as appropriate in the National Constitution as amended be corrected before final printing.

We recommend the following amendments to the Tau Beta Sigma National Constitution:

1.) Current 1.105

Tau Beta Sigma recognizes that the National Alumni Association of Kappa Kappa Psi Fraternity and Tau Beta Sigma Sorority is a separate entity within the corporation, and is responsible for National Alumni Association activities.

Current 3.403 A one hundred twenty (120) day written notice prior to the dates of all National Conventions shall be given to all National Officers, District Counselors, District Presidents, Chapters, and NAA Directors by the National Executive Director.

Current 5.306: The District Secretary-Treasurer shall record, publish, and distribute to all chapters in the District, the District

Counselor, all members of the National Council, and **the NAA Directors** representing the District, the minutes of all meetings of the District and shall, as necessary, control the receipt and disbursement of all monies of the District.

Current 5.504: A ninety (90) day written notice prior to the date of all District Conventions shall be given to all National Officers, District Counselors, District Officers, the NAA Directors representing the District, and Chapters in the District by the National Executive Director and the District Secretary-Treasurer.

Current: VII. Alumni Association

7.101 The goal of the National Alumni Association is to promote the ideals set forth in the National Constitution of Tau Beta Sigma; therefore, the Alumni Associations shall not in any way interfere with the local active chapters.

7.102 All Alumni Associations will fall under the jurisdiction of the National Alumni Association and the Constitution of the National Alumni Association. The Tau Beta Sigma Board of Trustees has direct authority over the National Alumni Association and its members.

7.103 Alumni Associations or individual alumni may not utilize the name of the Sorority in any form unless authorized by the National Council and National Alumni Association.

7.104 The Tau Beta Sigma members of the National Alumni Association Board shall be eligible to vote during the elections for the Board of Trustees at the National Convention.

Proposed 3.403 A one hundred twenty (120) day written notice prior to the dates of all National Conventions shall be given to all National Officers, District Counselors, District Presidents, Chapters, and by the National Executive Director.

Proposed 5.306: The District Secretary-Treasurer shall record, publish, and distribute to all chapters in the District, the District Counselor, all members of the National Council, the minutes of all meetings of the District and shall, as necessary, control the receipt and disbursement of all monies of the District.

Proposed 5.504: A ninety (90) day written notice prior to the date of all District Conventions shall be given to all National Officers, District Counselors, District Officers, and Chapters in the District by the National Executive Director and the District Secretary-Treasurer.

Rationale: NAA references need to be removed

2.) Current 3.801: A report of the activities conducted during the biennium shall be submitted by each National Officer, the Board of Trustees Chair, each District President, and the National Chapter Field Representative at each regularly called Conven-

tion of the National Chapter. Each Chairperson of a Standing or Special Committee shall submit a report of the activities of the Committee, together with the Committee's recommendations, at each convention of the National Chapter. **All reports shall be typewritten and submitted in triplicate.** One copy of all reports shall be filed at the National Headquarters by the National Executive Director.

Proposed 3.801: A report of the activities conducted during the biennium shall be submitted by each National Officer, the Board of Trustees Chair, each District President, and the National Chapter Field Representative at each regularly called Convention of the National Chapter. Each Chairperson of a Standing or Special Committee shall submit a report of the activities of the Committee, together with the Committee's recommendations, at each convention of the National Chapter. All reports shall be typewritten and submitted in hard copy to the National President and National Vice President of Communication and Recognition. An additional vice President of Communication and Recognition. One copy of all reports shall be filed at the National Headquarters by the National Executive Director.

Rationale: Submitting in electronic format will count as one format and written for VPCR to review. Additionally, this defines where the copies should go to in order to assist with minutes.

3.) Current 4.102: The National Intercollegiate Band(s) shall be open to all college band members, **college band directors**, and members of the Sorority.

Proposed 4.102: The National Intercollegiate Band(s) shall be open to all college band members and members of the Sorority.

Rationale: Current practice. We no longer have college band directors playing in the NIB. It should only be college students and/or members of the organizations. This is a historical reference to past participation and is not practiced.

4.) Current 5.302: Each District Officer shall be at least a sophomore student and an active member of the Sorority in good standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that **they are a Life Member**. Each District Officer shall have **more than an ordinary**-business or professional ability and shall be capable of representing the Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District Officers shall serve without compensation.

Proposed 5.302: Each District Officer shall be at least a sophomore student and an active member of the Sorority in good

standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that **they are a Life Member by September 1 of their term in office.** Each District Officer shall have **exceptional** business or professional ability and shall be capable of representing the Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District Officers shall serve without compensation.

Rationale: This sets a firm time line for those elected during their final year. Propose to change strike-through wording "more than ordinary" to "exceptional".

5.) Current 5.305: The District Vice President shall, in the absence of the District President, preside at the meetings of the District. The District Vice President shall also be in charge of **expansion** within the District as set forth by the guidelines of the District **Expansion** Committee.

Proposed 5.305: The District Vice President shall, in the absence of the District President, preside at the meetings of the District. The District Vice President shall also be in charge of **membership** within the District as set forth by the guidelines of the District **Membership** Committee.

Rationale: Maintains consistency with District officer title changes this spring. The 'District Expansion Committee' is also not listed in the standing committees outlined in 5.701. We propose that the word 'Expansion' be changed to 'Membership,' since that committee is being changed in 5.701.

6.) Current 6.602: ACTIVE. All active members of the Sorority shall be college or university students who are **enrolled/actively** participating in the band and have paid their current membership dues for the year. In the event a member of the Sorority is unable to **enroll/actively** participate in band, the person may continue as an active member for the academic term provided chapter members and sponsor so desire. An exception must be approved by the National President. Active members are eligible to hold office, serve on committees and take part in all business and social affairs of the chapter. Voting privileges will only be given to active and associate members.

Proposed 6.602: ACTIVE. All active members of the Sorority shall be college or university students who are **enrolled and actively** participating in the band and have paid their current membership dues for the year. In the event a member of the Sorority is unable to **enroll and actively** participate in band, the person may continue as an active member for the academic term provided chapter members and sponsor so desire. An exception must be approved by the National President. Active members are eligible to hold office, serve on committees

and take part in all business and social affairs of the chapter. Voting privileges will only be given to active and associate members.

Rationale: Current practice. This should help clarify that active members must do all three of the following: 1) enroll in a band, 2) participate in the band and 3) pay member dues. There is a process and another status for those who are not able to be active.

7.) Current 6.610: Membership Candidacy in the Sorority may be offered to students **enrolled/actively** participating in the college or university band. They shall possess unusually good character, and they shall be outstanding persons of leadership on the campus.

Proposed 6.610

Membership Candidacy in the Sorority may be offered to students **who are enrolled and actively participating** in the college or university band. They shall possess unusually good character, and they shall be outstanding persons of leadership on the campus.

Rationale: Current practice. This language should remain consistent with any changes to 6.602.

8.) Current 6.616: LIFE. Alumni or senior members, upon payment of Life Membership fees together with an application to the National Headquarters shall be entitled to Life Membership privileges in the Sorority providing their addresses are available at the National Headquarters. If application for Life Membership is requested within two (2) years of graduation, it must have chapter approval. Purchase of a Life Membership by a senior does not exempt a person from payment of annual membership dues during the senior year.

Proposed 6.616: LIFE. Alumni or senior members, upon payment of Life Membership fees together with an application to the National Headquarters shall be entitled to Life Membership privileges in the Sorority providing their addresses are available at the National Headquarters. If application for Life Membership is requested within two (2) years of graduation, it must have chapter approval. Purchase of a Life Membership by a senior does not exempt a person from payment of annual membership dues during the senior year **as the Life Membership will take effect upon graduation.**

Rationale: Current practice. Seniors who pay member dues remain active until National Headquarters changes the status in August of each year. Members may not hold dual status so therefore Life membership will take effect in August following graduation.

9.) Current 6.621: Any member of a Tau Beta Sigma chapter who has recently been an active member of that chapter is, upon transferring to another school, eligible to become an active member of the chapter. Active membership will be granted

to the candidate upon enrollment in the band program at the new school, presentation of current membership card, written recommendation from the candidate's previous chapter, a simple majority approval of the total eligible voting membership of the new chapter, payment chapter dues, and meeting the existing grade point requirement of the new chapter. If a written letter of recommendation from a member's previous chapter is not available, the new chapter's District Counselor must be contacted to research the transfer request. The District Counselor's decision will be made within thirty (30) days.

Proposed 6.621: Any member of a Tau Beta Sigma chapter who has recently been an active member of that chapter is, upon transferring to another school, eligible to become an active member of the chapter. Active membership will be granted to the candidate upon enrollment in the band program at the new school, presentation of current membership card, written recommendation from the candidate's previous chapter, simple majority approval of the total eligible voting membership of the new chapter, payment chapter dues, and meeting the existing grade point requirement of the new chapter. The letter of recommendation from the candidate's previous chapter must be sent to the new chapter and National **Headquarters.** If a written letter of recommendation from a member's previous chapter is not available, the new chapter's District Counselor must be contacted to research the transfer request. The District Counselor's decision will be made within thirty (30) days.

Rationale: National Headquarters will keep the transfer recommendation on file and send a copy to the National President as documentation of the transfer.

10.) Current 5.307: District Officers shall not have a vote, except the President whose vote shall only be counted to break a tie.

Proposed 5.307: Each District Officer shall have one vote at all meetings of the District Council, except the District President. The District President shall vote only when her/ his vote will affect the result or if the vote is by ballot.

Rationale: This is a district officer request. We would like to suggest that this be changed so that it is congruent with the chapter and national level voting procedures.

11.) Proposed 5.311: A District Officer may be removed from office by a unanimous vote of the remaining members of the district council and approval by the District Counselor. Upon removal from office, the National Headquarters and the National President shall receive notification of the removal within ten (10) days.

Rationale: This is current practice that needs to be defined in constitution.

12.) Current 5.701: The Standing Committees of the District shall be: Committee on Nominations, Committee on Convention Site, Committee on **Colonization and** Membership, and such other Committees as may be considered necessary by the District Counselor or by the District President.

Proposed 5.701: The Standing Committees of the District shall be: Committee on Nominations, Committee on Convention Site, **Committee on Membership**, and such other Committees as may be considered necessary by the District Counselor or by the District President.

Rationale: This committee is being renamed to membership to be consistent with current district practices.

13.) Current 5.801: All reports of District Officers and committee chairpersons shall be submitted typewritten in triplicate to the District Convention. One copy of each report shall be forwarded to the National Executive Director by the District Secretary-Treasurer to be included in the minutes of the convention.

Proposed 5.801: All reports of District Officers and committee chairpersons shall be **typewritten and submitted in a** hard copy format and an electronic format to the District Secretary-Treasurer. The District Secretary-Treasurer shall forward one copy of the complete convention minutes to the National Executive Director, National President, and National Vice President of Communication and Recognition.

Rationale: Current practice with technology and important to insure that documentation is kept in multiple sources in case officers are not able to gain the information from previous officers.

14.) Current 6.611: Any member of the Sorority shall be permitted to propose the name of a person eligible to become a membership candidate at chapter meetings. A **three-fourths** (3/4) vote of the total eligible voting membership shall be required to elect a person to membership candidacy.

Proposed 6.611: Any member of the Sorority shall be permitted to propose the name of a person eligible to become a membership candidate at chapter meetings. A **two-thirds (2/3)** vote of the total eligible voting membership shall be required to elect a person to membership candidacy.

Rationale: As stands it is currently more difficult to be asked to begin the membership education process (candidacy) than it is to terminate a person's candidacy. Changing the requirement to 2/3 rather than 3/4 would fix this discrepancy.

15.) Current 6.604: CONDITIONAL. Conditional status in the sorority may be maintained for up to one (1) academic year by a formerly active member in good standing. Conditional status

may be requested by an Active member, in writing, from the chapter when conflicts arise because of work or class schedules and thus prevent the student from fulfilling the requirements of active membership. The request shall be approved by the Sponsor and Director of Bands. The definition and term for Conditional Status shall not be altered on the local chapter level, nor shall Conditional status be imposed upon Actives to meeting obligations.

Proposed 6.604: CONDITIONAL. Conditional status in the sorority may be maintained for up to one (1) academic year by a formerly active member in good standing. Conditional status may be requested by an Active member, in writing, from the chapter when conflicts arise because of work or class schedules and thus prevent the student from fulfilling the requirements of active membership. The request shall be approved by the Sponsor and Director of Bands. Chapters may add requirements to Conditional membership upon a three-fourths (3/4) vote of the chapter to add an addendum to the chapter constitution and upon the approval of the Sponsor and Director of Bands. Chapters who elect to add additional requirements must notify their District Counselor within thirty (30) days. Conditional status may not be imposed upon Actives to meet obligations.

Rationale: This allows chapters to impose requirements on members requesting conditional status so as to keep conditional members at least somewhat involved and tied to the chapter. However, the process for altering the requirements is stringent enough (including notification of District Counselor) so as to prevent chapters from adding excessive requirements to conditional membership.

16.) Current 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their college or university.

Proposed 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their college or university. Active, Associate, and Conditional members may elect to become Alumni members upon completion of undergraduate education.

Rationale: This is current practice and is for clarification purposes only.

17.) Current 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their college or university.

Proposed 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their

college or university. If a member's collegiate education continues past four years, and she/he is unable to meet Active, Associate, or Conditional requirements, she/he may elect to have Alumni status, with Chapter and Sponsor approval.

Rationale: This allows students who may have more than the traditional four years of undergraduate study to become alumni at the same time their peers would. Note that this would be an individual's choice – they could also decide to meet Active, Associate, or Conditional requirements and thus maintain that membership status.

18.) Current 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their college or university.

Proposed 6.608: ALUMNI: Active, Associate, or Conditional members become Alumni members of the sorority when they complete their education or terminate their affiliation with their college or university. Alumni who obtain Alumni status through termination of their affiliation with their college or university without completion of an undergraduate degree shall not be able to retain Alumni status should they return to the same college or university for completion of undergraduate studies.

Rationale: Students who leave a school and then return to the same college/university for the same degree should be treated as if they were continuing members rather than alumni.

19.) Current 3.603: In the absence of a Delegate and an Alternate Delegate to a National Convention, each chapter may designate the Alternate Delegate of another chapter in attendance at the Convention to serve as its Proxy. The written proxy must be submitted to and approved by the National President one week prior to the opening session of the Convention.

Proposed 3.603: In the absence of a Delegate and an Alternate Delegate to a National Convention, each chapter may designate the Alternate Delegate of another chapter in attendance at the Convention to serve as its Proxy. The written proxy must be postmarked or received no later than two weeks prior to the opening session of the Convention.

Rationale: Request from National Council to 1) unify the dates and requirements for turning in proxy forms between Tau Beta Sigma and Kappa Kappa Psi and 2) have chapters turn these forms in a week earlier than as is current practice so as to streamline the proxy process.

20.) Current 6.605: INACTIVE Former active members who are enrolled in school, but do not pay Member Dues will be classified as inactive members. Inactive members are not considered

in good standing and therefore have no active membership privileges.

Proposed 6.605: INACTIVE Former active members who are enrolled in school, but do not pay Member Dues **and do not elect to become Alumni as per 6.608** will be classified as inactive members. Inactive members are not considered in good standing and therefore, have no active membership privileges.

Rationale: Fixing inconsistency due to change in 6.608.

21.) Affiliations

6.701 There shall be one affiliation of Tau Beta Sigma sorority: Graduate Student Affiliation.

6.702 Graduate Student Affiliation – In recognition of musical accomplishments, including service to music, music performance, and/or music education, students enrolled in a Masters or Doctoral graduate school music program may join or be given a Graduate Student Affiliation. Upon payment of annual dues, submitted with an application, and a letter of recommendation by her/his Director of Bands and/or supervising music faculty, the graduate student will be granted this affiliation. Undergraduates are ineligible for this affiliation.

6.703 Graduate Student Affiliates shall not have the privileges of membership in the sorority, except when a Graduate Student Affiliate also maintains a membership status with the sorority.

6.704 Affiliations provide individuals access to the professional network of Tau Beta Sigma, an electronic version of the Podium provided the affiliate's current email address is on file with National Headquarters, hard copies of National Intercollegiate Band recordings during her/his affiliation, and electronic access to previous National Intercollegiate Band recordings.

Rationale: Jurisdictional changes needed to implement item that the Membership Committee voted on and sent to Jurisdiction. Note, this is an affiliation, not a membership. It has its own section and does not appear in the Membership section.

Chapter Distance Award

The chapter whose members traveled collectively the farthest to National Convention is recognized; the distance between a chapter's school and the convention site is multiplied by the number of active members in attendance.

This year we are pleased to honor the **Eta Omega** Chapter for sending **5** members **2,725 miles** each for a total of 13,625 miles.

Chapter Participation Award

The chapter with greatest percentage of active members in attendance at National Convention is recognized; this number is based off the total active members attending divided by the total number of active members for the chapter. (Chapters within the host district—the Southeast District—are exempt.)

This year we are pleased to honor the **Epsilon Omega** Chapter from Morgan State University with the Chapter Participation Award for sending **5** of **12** members for a participation of **41.7%**.

District Participation Award

The chapter with greatest percentage of active members at National Convention is recognized; this number is based off the total active members attending divided by the total number of active members for the chapter. (The Southeast District is the host for this National Convention and is exempt.)

This year we are pleased to honor the **Western District** with the District Participation Award for sending **17 of 184 active members** for a participation of **9.2%**.

- Midwest District with 14 of 261 active members for a participation of 5.4%.
- North Central District with 41 of 551 active members for a participation of 7.44%.
- Northeast District with 48 of 542 active members for a participation of 8.9%.

Janet West Miller Delegate Distance Award

(Example: A University of Utah student who lives in Miami, Florida and attends National Convention in Orlando, Florida would only be awarded for the distance between Miami and Orlando.)

National Convention President Report

I think one of the best ways to start is to say that several plans and items were created to help build a network of tools for you and those who come into the bond after you to be welcomed into our Sorority. When I spoke to Dr. Greg Byrne prior to joining the council, he asked about expectations for the biennium, and I told him it was not my intent to have glory and accolades, but to lay a better foundation for tools that could be used in the years to come...an idea he much appreciated.

One area to focus on was the image of Tau Beta Sigma and our connections throughout the band community. I spoke with Dr. Byrne about my desire to gather directors that were supportive of Tau Beta Sigma to be able to utilize them for their knowledge. This could lead to more connections for contacts at professional conferences, help for existing sponsors on improving, information on what the council needs to focus on to help chapters, as well as working on colonization. Greg and I discussed many names and utilized the council and counselors to make the contacts we needed. There was a network created so that there are some commitments now across the country that we can turn to in each district as well as the national level. You will begin to see more in the future as this takes strides forward.

Along the same focus, we have worked with Women Band Directors International for several years now. I began discussing the connection more with their leadership during this biennium. We've had the opportunity now to discuss how we can be mutually beneficial to each other as we support music and our members may some day be their members. A great outcome of this has been being able to sit at a luncheon not hosted by TBS, but by WBDI and hear the glowing comments about the Sorority and how we can benefit them. It was a wonderful experience to know that we were being promoted by others to their peers. In addition, we have discussed creating a mentor project and utilizing their members as the mentors for some of our music education majors. They are on board and you will hear more about it over the week.

Yet another network to push forward was working on the OSMA recipients. We have great Women in Music who have received this reward yet we have not stayed in contact with all of them, promoted them, or utilized their knowledge. Dawn Farmer has been instrumental in this project. She has made great contact with these women who are pleased to know that Tau Beta Sigma is interested in them AND want to know what the Sorority is doing now. This becomes a great tool for us to use as they can help with Women in Music Speaker Series, mentoring, feedback from the band community, and the potential of helping us market ourselves for growth.

The National Council also worked on trying to bring our name forward at the Midwest Band and Orchestra Clinic. This included 2 proposals for clinics during the biennium. While neither was accepted, it has been a great learning process that I think we can move forward and try for another way to present our name to those leading bands. Additionally, one of the proposals was done with Women Band Directors International to utilized the resources we shared.

During this biennium, I also had challenges on the personal level as well as the Sorority. On the personal level, I honestly am to the point of wanting to share the issues as a 2 year span should not normally include 4 ER visits, 2 surgeries, 4 kidney stones, and 3 biopsies. While these were difficult issues, I had great support around me.

The support was there through the removal of a National Officer from the National Council as well. It is a time that I do not wish to repeat but also would follow the same action again in the same situation. In order to remove anyone from office, the national council does need to unanimously approve it and 75% of the Board of Trustees must also approve it. The information was gathered and the process was followed as per the constitution. Once one officer was removed, the vacancy needed to be filled. I received several great applications and worked on interview questions to ensure the best candidate who was ready to start now. Dawn Farmer was appointed and approved by the National Council. She joined us at our Summer Council meeting and I'd given her a few steps to start which she took, completed, and went steps further.

During the same summer meeting, a decision was made effecting the NAA. After the meeting, KKPsi was no longer affiliated with the NAA leaving a joint organization solely to Tau Beta Sigma. The council and board spent time discussing the next steps which led to the formation of a committee to create a new TBS alumni association. Ed Elsea, Leslie McClure, Chris Vanacore, Kimbi Sigle, Debbie Baker, and myself have all been involved and worked to form a new group. You will hear more about it as the week progresses. I appreciate all the help that those on the committee have given during this time and am pleased to see the direction being taken.

During this time I also traveled for the Sorority to many district conventions and 2 times to Midwest. I have been so pleased and honored to have the opportunity to represent you and meet you at these events.

Part of my position also entails working with the Board of Trustees. This is a group of people that I highly respect for the work that they do. I have been able to work with them on alumni, personnel, development, and through this learned of ways to work with donors. I did have an opportunity to approach a donor during this biennium who would like to give a sizeable donation, but we have not yet determined the best use.

My work cannot be completed without those around me. I have just mentioned the Board of Trustees and I am so thankful for them. In addition, I have had great counselors to work with to help both you, the students, as well as the National Council. I would like to thank Chris, Cathy, Kris, Iliana, Kathryn, Carolyn, Stacey, and Wendy. With 3 new counselors and 3 returning counselors, I had the opportunity to work with them to help pair the new people with someone to help them. Words cannot truly express how thankful I am. I encourage all future national leaders to continue to utilize the counselors appropriately and keep them informed. Their tie to the students is priceless and immeasurable. I will cherish the memories I have with each of you.

I was asked before my term as President started what I wanted my legacy to be by several people. To me, I honestly don't tend to think in those terms. Yes, goals to accomplish, but didn't totally grasp that the perception is there that it's a legacy. It finally hit me when I turned in a bio for the National President list that you all see on the web or in the Resources that you download and that I saw in the books the Sorority once printed to send out to chapters...realizing that my name was now among those I had learned about as a candidate or met while I was an active, and I was no longer just in that "someday it could be possible" world.

My next comment is to you, the students. Each biennium, I've given a reminder, a reminder that you will be in charge some day and one of you will be a national officer some day. While I still give you that charge, let me expand it. Many of you are here and excited and love what's happening with the direction of the Sorority. To you, I say bring forward that passion this week and drive the business here. Learn how you can take what you love and build it. It is because of your passion that we can grow. For those of you who may have questions about the Sorority and it's direction...I have advice for you as well...you can be here and be upset and do nothing...or you can take what you feel is wrong, learn about how to make the changes, then make the plan to do it. Questions are also what makes us grow. All I ask for the week from any of you no matter where your mind set is is to make this convention YOURS. This is YOUR organization... I know you are there and know there are great discussions amongst your leaders...I know you can take Tau Beta Sigma to where you want it to be in 5, 10, 50, and 100 years.

My time involved in the Sorority and drive to begin started back as a student seeing leaders that I respected along with changes that I wanted to make. I saw the great things this group could do and the many things that we could do to hurt ourselves. I brought with me today a shirt from my last national conven-

tion as a student that was held in Orlando. At that time, I knew that I need to continue on serving and make the changes that needed to be made, or just walk away. I had too much love for the organization to leave it and knew too many students would miss the great bond we share.

While involved on the councils I have seen the organization move towards online meetings and played an integral role in doing so. I've watched tragedies happen with September 11th, hurricanes, and Virginia Tech and seen how we as sisters and brothers can come together in support. I have strived to maintain a balance between seeing the organization as a Corporation and as a Sisterhood and challenge each of you to continue to do so.

Through out it all, I've still tried to maintain focus on the students. This included the creation of the Baton, watching students develop, and encouraging students to follow on the path wherever it may lead them. In it all, there has been respect on both sides. Respect of authority without thought leads us to complacency, yet as sisters, we can disagree while still allowing respect to each other.

I have many thanks to give and I don't know if I can make it through it all. I'll try not to forget anyone. I've said thank to the counselors already and again, so much fun, knowledge, laughter, and tears shared with each of you. I thank many members of KKPsi who have offered support over the years and am glad to have had an opportunity to work with them including Rod during these last 4 years. To the many presidents before me I thank you for your guidance and insight. To the Board of Trustees, thanks for your help during the biennium. I know there were difficult decisions to be made and appreciate your work, time, and love for the Sorority.

Meredith, you bring so much to this position of CFR. I'm glad to have worked with you and see bright things for your future. Greg, while not here at the moment, deserves many thanks. He has brought new insight and enthusiasm to the position. I saw him starting off a new colony and have seen the drive grow. He has stood up for Tau Beta Sigma on many occasions and I am grateful for him.

I remember Kimbi as a student and working with her then. It's been a great pleasure to work with you and see you from our first National Convention in 1993 to the desire to make changes in 1995 to where we've grown to today. I wish you the best with the future of the organization and thank you for your friendship.

Dollie was a great student leader. I'm in awe of where she has come to. I remember her asking me to come to interview with the nominations committee and her passion for Tau Beta Sigma. I know that you will do amazing things for this group. I love the time I've spent with you and will miss it.

Dawn, I know you stepped into the position mid-way through. I hope you saw then and have seen throughout how much I

have appreciated you and how much the rest of the council has appreciated you. You've been a great addition to the council and made everything run so smoothly. Your initiative and drive have made each step requested of you go that much further for the Sorority. The Sorority has great opportunities for success with you involved.

While I've said thanks to both Kimbi and Kris, I have an additional thank you. They've both been involved in TBS at the same time and same places as I have. I can't believe we were students once and are holding these roles now. I am so grateful to both of you for all the support and friendship and am glad that I joined an organization that led me to such wonderful people.

From this point, I leave you knowing that times have been great but also a few difficult moments as well. Music has been an integral part of my life since I was a small child and Tau Beta Sigma helped me continue that interest and share it with others. I thank you for this time to serve and will miss this part, but am looking forward to the next step and seeing one of you students out there now standing up at the podium in the future.

Appendix X: Final Report of the Nominations Committee

Final Report of the Committee on Nominations By Amy Bovin, Chair Gamma Kappa Chapter, University of Connecticut, NED President

The Nominations Committee was charged with the following:

- 1) Review the report of the 2005 Nominations Committee
- 2) Review National Officer Candidate Form to determine is any additional items should be added.
- Determine the eligibility of the candidates for National Council as outlined in the Tau Beta Sigma National Constitution.
- 4) Develop interview procedures, formulate questions and schedule interview times for all candidates for national office.
- 5) Recommend a slate of candidates for national office.

The criteria for determining the eligibility of the candidates for National Office as set forth in the 2005 National Constitution are:

Sections 3.203 Each National Officer shall be a Life Member of the Sorority in good standing and at least twenty-five (25) years of age at the time of election. Each National Officer shall have completed an undergraduate degree program. Each National Officer shall possess outstanding business ability and shall be capable of representing the Sorority under all ordinary conditions. All shall be willing and able to devote the necessary time to the execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office.

3.204 Each National Officer shall serve for a period of two (2) years from convention to convention. The National Vice President for Colonization and Membership shall be advanced to the office of National President provided said officer receives a simple majority vote of the convention. The National President and Vice President for Colonization and Membership shall not be eligible for reelection.

After ensuring each candidates' eligibility for office, the candidates required to appear for at least a twenty (20) minute personal interview with the Committee. The Nominations Committee composed and asked the following questions to the candidates of Vice President of Colonization and Membership, Vice President of Special Projects, and Vice President of Communication and Recognition:

- Are there any offices you would not like to be slated for?
- 2. If elected, what is the first thing you plan on doing in your office?
- 3. What goals do you see for the future of the sorority in the next two years, and the next five years?
- 4. What problems do you see now that you want to fix?
- 5. What role do you feel the alumni should have on the national level?
- 6. What are your other priorities outside of the sorority?
- 7. What new ideas do you have for your office?
- 8. What is your understanding of what your position entails?
- 9. How do you actively plan to continue serving your band when elected?
- 10. What are your greatest strengths and limitations?
- 11. What are the most important aspects of TBS on the national level?
- 12. How do you plan to make the sorority more fiscally responsible?
- 13. How do you plan to pick up where the other officer left off?

The following questions were asked to the candidates for the office of President:

- 1. If elected what is the first thing you plan on doing in your office?
- 2. What goals do you see for the future sorority in the next two years, and the next five years?
- 3. What problems do you see now that you want to fix?
- 4. How do you plan on making the sorority more fiscally responsible?

- 5. How to you intend to develop a more open line of (and improve the) communication with KKY?
- 6. How do you plan on integrating the student's voice with your plans for national council?
- 7. What role do you feel the alumni should have on the national level?
- 8. What are the most important aspects of TBS on a national level?
- 9. What are your greatest strength and limitations?
- 10. Why do you feel you should be the next national president?
- 11. What new ideas do you have for your office?

Each candidate was also required to attend a "Meet the Candidates" forum for the entire delegation. Each candidate was given two (2) minutes to present their platform to the delegation. A five (5) minute question and answer period followed. During the election, the Nominations Committee recommends the allotment of two (2) minute's time for any candidates nominated from the floor to present their platform. The Nominations Committee found that all candidates met the criteria set forth by the National Constitution. After very careful consideration, much deliberation, and keeping in mind what is best for the sorority, the Committee would like to recommend the following slate of officers for the National Council:

President - Kimbi Sigle

Vice President of Colonization and Membership – Dollie Mc-Donald

Vice President of Special Projects - Dawn Farmer

Vice President of Communication and Recognition – Deena Smith

The Nominations Committee also reviewed and made changes to the single page data sheet put together by the previous Nominations committee. The purpose of the data sheet is to provide the candidates' information that demonstrates their eligibility in order to simplify the work required of the Committee by the National Constitution. The Committee recommends that any future candidate submit this sheet along with their packet no later than the end of the second separate session at National Convention

The Nominations Committee made the following charges:

- For all National Officers to increase communication between the National Council, the Districts and the chapters as to reasoning behind decisions
- For all National Officers to find a way to effectively communicate all national initiatives to the Districts and the chapters
- For each member of the National Council to contact at least 2 different chapters each month
- For the districts and the chapters to stay in contact with their National Council, especially when there are concerns

- For the National President to keep the students' voice in mind at all times
- For the National Vice President of Colonization and Membership to present ways to recruit quality members
- For the 2009 Nominations Committee to keep in mind what is best for the sorority at all times

The committee would like to thank Carolyn Steckel for sharing her advice through out the week. I would also like to thank the rest of my committee for staying positive, working together, and for bringing many laughs into the committee meetings.
